PDL students are adults with 64% having a military affiliation, 14% Hispanic, with 61% of the students taking their courses online.

Responsible for the leadership of Park Distance Learning. Served as the chief academic/operations officer (direct report to Provost) for PDL, served approximately 22,000 post-traditional students which included the divisions of Online Learning (average enrollment of 50,000 annually) and Extended Learning at 35 campus centers in 21 states. Responsible for strategic initiatives and oversight of the supervision team for day-to-day operations and academic quality online and extended campus centers. PDL had an annual operating budget of approximately \$30 million. As Dean, I had oversight of approximately 165 employees and 1,200 adjunct instructors globally. Responsible for adjunct faculty overload requests, student withdrawal approvals, student grade appeals, other administrative daily approvals, and oversight of the academic quality of programs delivered through PDL. As Dean, I was also responsible for marketing, admissions, student call center, and ensuring the academic integrity of degree programs at military instillations. Oversaw extended campus and academic directors to ensure

compliance with policy, procedures, accreditation, and DOD standards. Served as liaison between PDL and Parkville campus administration and academic deans. Monitored DOD and federal initiatives through the Director of Military and Federal Programs. Reviewed and established policy and procedures to ensure a high level of academic quality for all courses and faculty. Accomplishments:

- Revised the organizational structure allowing for cohesive oversight of the daily operations at campus centers;
- Conducted an environmental scan in preparation for strategic planning;
- Established a strategic planning initiative to align with the Park two year plan;
- Established a monthly training program for the campus center administration and academic directors;
