The New Mexico Highlands University Board of Regents held a special virtual meeting on December 22, 2023. The meeting notice and agenda were posted in compliance with the open meetings act on December 19, 2023.

Call to Order – Chairman Garcia called the meeting to order at 10:15 a.m.

Numerous faculty members, staff, students, community members, and public participated in the meeting as it was live streamed.

Compliance with Open Meeting Notice Requirements

Chairman Garcia stated that in accordance with the Open Meetings Act, the December 22, 2023, special virtual meeting notice and agenda with the meeting date, time, and place were posted timely and in compliance with the NMHU Board of Regents Open Meetings Act Resolution.

Approval of the December 22, 2023 Agenda

Regent Lucero moved to approve the December 22, 2023, Special Virtual Meeting Agenda as presented. Regent Rivera seconded. Voting in favor: Regent Lucero, Regent Rivera, Regent Sanchez, Regent Smith, and Chairman Garcia. Motion carried.

Regent Lucero moved to enter into executive session for the sole purpose of discussing the item listed. Regent Rivera seconded. Voting in favor: Regent Lucero, Regent Rivera, Regent Sanchez, Regent Smith, and Chairman Garcia. Motion carried and the Board entered into executive session at 10:20 a.m.

Regent Lucero moved to return to open session and stated, for the record, that only the item listed under the executive session action item was discussed and no action was taken. Regent Rivera seconded. Voting in favor were: Regent Lucero, Regent Rivera, Regent Sanchez, Regent Smith, and Chairman Garcia. Motion carried and the Board went into open session at 10:33 a.m.

The Board thanked Dr. Kempner for an outstanding job leading the search committee effort. The search firm commented that Dr. Kempner was the best search chair they have worked with. The Board thanked the Presidential Search Committee for their devotion and all of the time and effort they put forth during the entire search process.

Possible Action and Statements as Necessary on Executive Session Discussion – Action Item

Regent Smith moved to enter into an employment agreement with Dr. Neil Woolf who was selected as the 23rd President of New Mexico Highlands University by the Board of Regents. Regent Lucero seconded. A roll call vote was taken and voting in favor of hiring Dr. Neil Woolf were Regent Lucero, Regent Rivera, Regent Sanchez, Regent Smith, and Chairman Garcia.

Dr. Neil Woolf thanked Chairman Garcia and the Board for selecting him as the next President of New Mexico Highlands University. Stating he was honored and humbled. He thanked Dr. Kempner and the search committee for their hospitality. He stated that he is looking forward to serving the university and becoming a member of the Las Vegas community.

Regent Smith welcomed Dr. Woolf you to New Mexico Highlands University. She remarked that she looks forward to working with him and thinks he will take Highlands to its next level of excellence.

Regent Lucero thanked Dr. Woolf for going through the intense application process. He is excited for all the ways Dr. Woolf's experience, vision, and skill set aligns with the university's mission.


Regent Rivera indicated that he is looking forward to working with Dr. Woolf.
